The Dr. H.S. Trefry Memorial Centre staff have been developing a program for its clients and community members to participate in physical and social recreation though a supported swim and social program. This program would support registration, transportation and staff supported attendance at a swim and social program at the YMCA in Sault Ste. Marie. The program would run once weekly on Mondays for 24 weeks. For 40 participants per week, transportation and program costs would be \$1,184 per session. The total funding required for the program for 24 weeks would be \$28,416.00. The Seniors and Persons with a Disability Advisory Committee was presented with the program and funding options at their meeting on January 10th.

The Resilient Communities stream of funding from the Trillium Foundation supports organizations to adapt or add a new program and service delivery to meet the changing needs of the community including program implementation. The application is due on February 1, 2023.

The Ministry for Seniors and Accessibility Grant - Seniors Community Grant supports The Seniors Community Grant Program funds local not-for-profit community groups and organizations to deliver projects, supports and resources that help older adults (aged 55+) to: live independently, live with safety and security, stay connected to their community, avoid isolation and achieve greater financial security and social connections.

Financial Implications:

This Trillium Foundation will fund up to 100% of eligible expenses between \$10,000 and \$100,000. The program costs are eligible expenses. The Ministry for Seniors - Seniors Community Grant funds up to \$25,000 and 100% of eligible expenses.

Options:

Council may approve staff to apply for both funds or may defer or deny the request to apply for this funding.

MPP Michael Mantha's office shared information about Hydro One's Energizing Life Community Fund. Qualified organizations can submit applications for up to \$25,000 for funding towards initiatives that promote physical, psychological, and emotional well-being.

The Dr. H.S. Memorial Trefry Centre is developing a support program for youth with disabilities called The Open Hearts Club. The program's mission is to empower and teach youth with disabilities the skills needed for independence while fostering a connection to their community, peer, and their own self-worth. The Senior's and persons with a Disability Advisory Committee met on January 10th and

The Open Hearts Club will focus on teaching life and social skills to persons with intellectual disabilities who are transitioning into adulthood, moving forward in living independently or have aged out of the education system. Topics will be broken into life skills towards independence, relationships and social development, safety aspects related to finance, security and the online world, as well as practical life skills including hygiene, housekeeping, cooking and transportation planning. The program will have guest speakers from the community, lunch and learns, field trips, and collaboration with other programs and services in our area. The club will include hands on participation, creative exploration, and individualized programming to meet the goals of the group members.

Applications for the fund are due January 31st, 2023.

Financial Implications

Funding of \$25,000 would be applied to the program for staffing, materials and supplies, guest speakers and transportation. At this time, it is not expected that any funding will be required from municipal resources.

Summary

Council may approve the application of funds, defer the decision, or consider other options.

The Charged for Change program through financial support from Aviva Canada Inc. offers funding to underserviced Communities in the Province of Ontario to install Electric Vehicle Charging Stations.

Communities may receive up to \$250,000 for eligible expenses to complete the project. Eligible communities must have less than 100,000 residents and have less than the provincial average number of charging stations per capita (less than one (1) charging station per 8,610 people).

Previously the Township of St. Joseph released a request for proposal for the supply and installation of charging stations, and a number of locations were identified for future installations. This information can be found in the "RFP Level II EV Charging Stations" document.

Financial Implications:

Eligible expenses include salaries, professional services, capital expenses, license fees and permits, environmental assessments to a maximum of \$250,000. Ineligible expenses include Land costs, legal costs, and ongoing operating costs such as electricity and networking/subscription fees.

By-Law enforcement has been an issue within the municipality. In addition to making changes to existing by-laws and introducing the administrative penalties system in the future, employing a certified enforcement officer will certify the BLE under the Provincial Offices Act, allowing the issuance of fines/tickets. The course will also focus on key areas of the position, best practices, and the authority/powers of by-law enforcement officers.

The current BLE is also employed by the Village of Hilton Beach, which is willing to share the cost of the course \$675.00 + tax. (Split 75% - St. Joseph, 25% Hilton Beach based on population and usage).

A member of the Recreation Committee, in consultation with staff proposes a new event to be held this summer at various Township sport facilities in Richards Landing. Please see the attached letter. The Trisport event would involve registered teams competing in three sports — Beach Volleyball, Slow Pitch Baseball, and Ball Hockey over a period of two days. Teams of 10-12 would pre-register for a fee that would support the expenses for the event as well as cash prizes for the tournament winning teams. The purpose of the event is to increase use of our municipal sports facilities, encourage new visitors to the area, and encourage physical activity and love of sport. The tournament occurs on the same weekend as the Go North Music Festival offering registrants the option of evening entertainment and the opportunity to take advantage of the campground.

The tournament would be promoted directly to a number of recreation leagues in the area. Volunteers will be required to assist with logistics and support for the event.

Financial Implications:

Staff support and a material budget for sand would need to be provided by the Township to create the volleyball court at the Centennial Grounds. The Recreation Committee has recommended the addition of this item to the Recreation Project budget for 2023. The intention of the event is to be fully self-funded, with any budget surpluses to be donated to the PSW Outreach program to support its services. The budget for the event is attached.

Dear Head of Council:

Ontario's housing supply crisis is a problem which has been decades in the making. It will take both short-term strategies and long-term commitment from all levels of government, the private sector, and not-for-profits to drive change. Each entity will have to do their part to be part of the solution.

To help support this important priority, I am pleased to provide you with an update on recent legislative and regulatory changes our government has made to help get 1.5 million homes built over the next 10 years.

Bill 109, the More Homes for Everyone Act, 2022

Bill 109, the More Homes for Everyone Act, 2022, was introduced on March 30, 2022 and received Royal Assent on April 14, 2022.

As part of the government's More Homes for Everyone Plan, Schedule 5 of Bill 109 made changes to the Planning Act. Consequential changes were also made to the City of Toronto Act. 2006.

Most of the Planning Act changes are now in effect except for the zoning and site plan control fee refund provisions, which are due to come into force on January 1, 2023. However, I am committed to bringing forward legislation to delay the effective date of the fee refund changes from January 1, 2023 to July 1, 2023. These legislative changes would be introduced in the new year.

In the event that any fee refunds become due to applicants before these legislative changes are made, municipalities might consider not issuing refunds in the interim given my express commitment to introduce legislation that, if passed, would retroactively cancel the requirement.

Bill 23, More Homes Built Faster, 2022

Bill 23, the More Homes Built Faster Act, 2022, was introduced on October 25, 2022, and received Royal Assent on November 28, 2022.

To support More Homes Built Faster: Ontario's Housing Supply Action Plan: 2022–2023, Schedule 9 of Bill 23 made changes to the Planning Act. Schedule 1 of Bill 23 also made similar changes to the City of Toronto Act, 2006 related to site plan provisions. Schedule 3 of Bill 23 made changes to the Development Charges Act.

The planning-related and municipal development-related charges changes came into force on November 28, 2022, except for provisions related to removal of planning responsibilities from certain upper-tier municipalities, certain provisions related to parkland dedication, and exemptions from municipal development-related charges for affordable and attainable housing, which will come into force on a day in the future to be named by proclamation. Provisions related to Conservation Authorities will take effect January 1, 2023.

Bill 23 also made changes to legislation led by other ministries. Please see Appendix A for an overview of the effective dates of the Bill 23 changes by schedule.

Bill 3, the Strong Mayors, Building Homes Act, 2022 and Bill 39, the Better Municipal Governance Act, 2022

Bill 3, the Strong Mayors, Building Homes Act, 2022, was introduced on August 10, 2022, and received Royal Assent on September 8, 2022. Bill 3 and associated regulations (O. Reg. 529/22 and O. Reg. 530/22) came into force on November 23, 2022.

Bill 39, the Better Municipal Governance Act, 2022, was introduced on November 16, 2022, and received Royal Assent on December 8, 2022. Bill 39, amendments to associated regulations (O. Reg. 581/22 and O. Reg. 583/22), and additional regulations to prescribe provincial priorities (O. Reg. 580/22 and O. Reg. 582/22) came into force on December 20, 2022. Additional details can be found in Appendix B and on the Ontario Legislative Assembly's website (Bill 3 and Bill 39).

Appendix B

Bill 3, the Strong Mayors, Building Homes Act, 2022 and Bill 39, the Better Municipal Governance Act, 2022

As a result of Bills 3 and 39, changes were made to the Municipal Act, 2001, City of Toronto Act, 2006 and the Municipal Conflict of Interest Act, and regulations were established to give the mayors in Toronto and Ottawa strong mayor powers to help advance shared provincial-municipal priorities, including building new homes. These powers include:

- Choosing to appoint the municipality's chief administrative officer,
- Hiring certain municipal department heads, and establish and re-organize departments,
- Creating committees of council, assigning their functions and appointing the Chairs and Vice-Chairs of committees of council, and
- Proposing the municipal budget, subject to council amendments and a head of council veto and council override process.

The mayors of Toronto and Ottawa can also use strong mayor powers related to provincial priorities. These include:

- Vetoing certain by-laws if the mayor is of the opinion that all or part of the by-law could potentially interfere with a provincial priority,
- Bringing forward matters for council consideration if the mayor is of the opinion that considering the matter could potentially advance a provincial priority, and
- Proposing certain municipal by-laws if the mayor is of the opinion that the proposed bylaw could potentially advance a provincial priority. Council can pass these by-laws if more than one-third of council members vote in favour.

The provincial priorities for the purposes of strong mayor powers are prescribed in O. Reg. 580/22 and O. Reg. 582/22 and they are:

- 1. Building 1.5 million new residential units by December 31, 2031.
- 2. Constructing and maintaining infrastructure to support housing, including, transit, roads, utilities, and servicing.

THAT the Officers of the Municipality may from time to time assign, transfer, convey, hypothecate, mortgage, pledge, charge or give security in any manner upon all or any of the real of personal, moveable or immoveable property rights, powers, closes in action, or other assets, present or future, of the Municipality to secure any such securities or other securities of the Municipality or any money borrowed or to be borrowed or any obligations or liabilities as aforesaid or otherwise of the Municipality heretofore, now or hereafter made or incurred directly or indirectly or otherwise.
- 4. THAT any or all of the foregoing powers may, from time to time be delegated by the Officers to any one or more of the Officers of the Municipality.
- 5. THAT should any section, subsection, clause, paragraph or provision of this By-law be declared by a court of competent jurisdiction to be invalid or unenforceable, the same shall not affect the validity or enforceability of any other provision of this by-law or the by-law as a whole.
- 6. THAT this By-law shall remain in force and be binding upon the Municipality as regards any person acting upon the faith of a copy of this By-law certified by the Clerk of the Municipality until such person has received written notification from the company that this By-law has been repealed or replaced.
- 7. THAT any by-law or portion thereof previously approved by Council which conflicts with this By-law shall be hereby repealed.
- 8. THAT this By-law shall take effect on the day of passing.

BY-LAW 2023 - 06

A BY-LAW TO PROVIDE FOR AN INTERIM TAX LEVY FOR THE YEAR 2023

WHEREAS Section 317(1) of the Municipal Act, 2001, as amended, provides that a local municipality may, before the adoption of the estimates for the year, pass a by-law levying amounts on the assessment of property in the local municipality rateable for local municipality purposes; and

WHEREAS the Council of the Corporation of The Township of St. Joseph deems it desirous and expedient to impose an interim levy for the year 2023; and

NOWTHEREFORE the Council of the Corporation of The Township of St. Joseph enacts as follows:

- Interim tax levies for the year 2023 shall be imposed and levied on the whole of the assessment
 for real property in all property classes, according to the last revised assessment roll, an amount
 equal to 50 per cent of the sum that would be produced by applying the total 2022 tax rate for the
 subject property class.
- 2. Notwithstanding the provisions of Section 1 of this By-law, the amount levied on a property shall not exceed 50 percent of the total amount of taxes for municipal and school purposes levied on the property for the previous year.
- 3. The 2023 interim tax levy shall become due and payable on February 28, 2023.
- 4. Any interim tax levy, or portion thereof, which is in default with the stated due date shall be subject to a penalty charge of 1½% on the first day of default and on the first day of each month thereafter in the current year unless sooner paid.
- 5. All taxes remaining unpaid after the end of the current year shall have interest added at the rate of 1½% per month, for each month or fraction thereof in which the arrears continue.
- 6. Taxes are payable to The Township of St. Joseph Municipal Office at Richards Landing, Ontario and payment shall only be accepted in CANADIAN FUNDS.
