

BE IT RESOLVED THAT the report from the Office Assistant / Healthy Living Coordinator regarding a new proposed event at the Municipal Marina and Cenotaph Park be received; and

THAT council authorizes staff to allow the Marina Deck Caterer to host a licensed event August 13, 2021 in conjunction with fundraising efforts by the NSHN Richards Landing Auxiliary.

Background:

The caterer for the licensed patio area during the Arts and Craft Beer events would like to host a Mini Festival of Beer at the Cenotaph Park between 12 noon and 6pm on Saturday August 13th. The event would consist of 4 tasting stations with various craft beer options. All Liquor License regulations would be followed and coordinated under the Catering License. The event would also include a live music component provided by LopLops. The Maker's market area would be maintained and the event would be in addition.

Loplops indicated they would be interested in partnering with a local charity to assist with fundraising in this difficult time. The Healthy Living Coordinator approached the NSHN Richards Landing Auxiliary to see if they would also be interested in fundraising at this event, due to the cancellation of Community Night, and they were receptive. Specifics of their fundraising efforts are to be determined, but may include a traditional Community night game(s) or volunteer donation collection, similar to the Community Night fireworks event in 2019.

Financial Implications:

Staff time and minimal promotion expenses are the two resources required from the Township. Staff time should be very minimal to assist with any promotions of the event. The fee structure of 10% of profits would extend to Loplops for this event.

Options:

Council may approve the proposed activities above, or may amend, defer or deny the request.

Dear Council of St. Joseph Township,

AlgomaTrad is currently planning the annual Family Camp for Aug. 9-14 at 1249 F&G Line under guidelines and direction from Algoma Public Health. To follow APH guidelines we are attempting to create as many outdoor workshop spaces as possible. It has been a challenge procuring enough tents that would help us create enough spaces and would like to know if Council would consider renting 2 of their 20x20 tents for this purpose. We understand the reluctance of the township to rent these outside of township events but are hoping that, with the present situation due to COVID-19 and that we ask this only in terms of helping to make the AlgomaTrad Family Camp a safe space, you might consider this request.

The AlgomaTrad Family Camp is expecting approximately 100 participants this year, lower numbers than usual so we can more easily maintain public health protocols, and is committed to providing a safe and secure experience for everyone. We apologize for the lateness in this request but it has been a challenge to make plans due to shifting and unknown details of each phase of the province's recovery plan. Algoma Public Health has been very positive and encouraging throughout our process of decision-making and planning.

We appreciate your consideration in this matter and we look forward to hearing from you at your earliest possible convenience. AlgomaTrad has always appreciated the support received from the Township of St. Joseph over the years and values the relationship. If the Township does allow us to rent the tents, we would of course follow any direction from the Township in terms of making sure the tents are returned to you in the same condition that we received them.

BY-LAW 2021 - 29

A BY-LAW TO SET THE RATES OF TAXATION FOR THE YEAR 2021

WHEREAS pursuant to section 9 of the *Municipal Act*, 2001, S.O. 2001, c.25, as amended, a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act; and

WHEREAS pursuant to section 8(1) of the *Municipal Act*, the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate to enhance the municipality's ability to respond to municipal issues; and

WHEREAS Council passed By-law No. 2021-14 in accordance with section 308(5) of the *Municipal Act* which established the Tax Ratios to be used by the Township; and

WHEREAS Tax Rates to be used by single-tier municipalities to determine the amount of taxes to be raised for the Education Levy have been set by the Province,

NOW THEREFORE be it hereby enacted by the Council of The Corporation of The Township of St Joseph as follows:

- 1. That, for the year 2021, the estimate of all sums required for municipal purposes is as set forth in Schedule "A" as attached hereto and forming part of this By-law.
- 2. That for the year 2021, there shall be levied and collected upon the assessments in each property class, the rates of taxation as contained in Schedule "B" as attached hereto and forming part of this By-law.
- 3. In calculating the 2021 taxes as authorized herein, the Treasurer shall reduce the taxes by the interim amount billed as per Section 312 of the *Municipal Act*. The balance of the property taxes shall become due in one installment payable August 31, 2021.
- 4. A penalty shall be imposed for nonpayment of taxes on the due date, at the rate of 1.25% of the amount due on the first day of default and on the first day of each calendar month thereafter in which default continues.
- 5. After December 31, 2021, the Treasurer shall add interest at the rate of 1.25% per month on all taxes due and unpaid.
- 6. The Treasurer is hereby instructed to mail, or cause to be mailed, the notices of taxes due to the address of the residence or place of business of the person to whom such a notice is required to be given, as it appears in the last revised Assessment Roll for The Township of St Joseph.

- 7. Taxes shall be payable to The Corporation of The Township of St Joseph at 1669 Arthur St, Box 187, Richards Landing, ON, POR 1JO or through internet or telephone banking with most Credit Unions and Chartered Banks.
- 8. The Treasurer may accept part payment on account of any taxes due from time to time and apply such payments to outstanding balances.
- 9. The Treasurer is hereby authorized to adjust the billing schedule if required to comply with Provincial legislation or regulations which may be received after the passing of the By-law.
- 10. That this By-law shall take effect on the date of passing.

BY-LAW 2021-30

A By-Law to Confirm the Proceedings of the Special Council Meeting held on July 26, 2021.

WHEREAS the Municipal Act. 2001, S.O. 2001, c25, as amended, provides that a municipal Council shall exercise its powers by by-law, except where otherwise provided; and

WHEREAS in many cases, action which is taken or authorized by Council to be taken does not lend itself to an individual by-law;

NOW THEREFORE the Council of the Corporation of the Township of St. Joseph hereby enacts as follows:

- 1. That the actions of the Council of the Corporation of the Township of St. Joseph at its meeting on July 26, 2021, in respect to each motion, resolution, direction and other action passed and taken by Council, except where the prior approval of the Ontario Municipal Board is required, is hereby adopted, ratified, and confirmed.
- 2. That the Mayor and the proper officers of the Corporation are hereby authorized and directed to do all things necessary to give effect to the said action or actions, to obtain approvals where required, and to execute all documents as may be necessary, and to affix the corporate seal to all such documents as required.
