Background:

In 2022 there were reserve funds allocated to the Children's Library for Deck Repair and Siding Replacement. The NOHFC grant secured in 2022 will cover 90% of the costs for these items. This reserve funding could be reallocated to allow the replacement of the current oil furnace with a new more efficient electric furnace.

There are sufficient funds available to reasonably complete the project with funds remaining.

Options:

Council may approve staff to prepare an RFQ for the replacement of the furnace or may suggest amendments or defer.

Background

The Township of St. Joseph has run a number of Freon Removal events over the last 5 years to help residents properly dispose of their fridges, freezers, ac units and other freon containing appliances at the landfill. This system did not consistently result in the minimum number of units required for it to be revenue neutral.

The cost to remove freon is currently \$35/unit. Additional costs include production of stickers indicating the removal fee has been paid, and the administration of the program. In order to recuperate these expenses, the fee to the end user would be \$40/unit.

Stickers must be purchased and recorded at the Township Office.

Financial Implications

The new pre-purchased freon removal system will be revenue neutral.

Summary

Council may accept the recommendation as presented or consider other options.

Special Occasion Permit

The Go North Music Festival intends to sell alcohol again in 2023. The Go North Music Festival requires council approval to apply for a Special Occasion Permit (SOP). The Liquor Control Board of Ontario also requires a resolution recognizing and approving this event as a significant community event.

Noise By-Law

The Go North Music Festival intends to end the main stage at approximately 11:30 pm on July 7th and 8th, 2023. The Noise By-Law provides that amplified music shall not exceed/surpass 11pm. The Committee requests an exemption from the By-Law until midnight.

The campfire stage is planned to occur between the hours of 11:30pm and 2am. Music will not be amplified. It is anticipated that acoustic campfire music will continue until 2am but will not be a nuisance.

The Richards Landing Events and Cultural Committee requests Council to authorize an exemption from the Noise By-Law for these dates to facilitate an enjoyable festival and campground music experience for the campers. Public notice can be provided if council deems it preferable.

Options:

Council may approve the noise by-law exemption for the main stage as presented: or may suggest amendments to the exemption.



WHEREAS on December 1, 2022 the Ministry of Health has implemented an 80% reduction in virtual physician fees;

WHEREAS the reason for this reduction is due to the shortage of family doctors in Ontario which disproportionately affects the north with many small communities without one at all;

WHEREAS at present there are six walk in clinics in Sault Ste Marie where a doctor can be accessed virtually under the supervision of a Registered Nurse;

WHEREAS these clinics can order routine screening tests, renew prescriptions and provide care with such things as sore throats, diabetes maintenance, and urinary track infections. Those needing more serious care are referred to the Emergency Room at the local hospital.

WHEREAS the Emergency Departments at most hospitals are currently overloaded due to staffing shortages, attrition and/or illness.

WHEREAS, these virtual clinics reduce stress and increase safety to patients with minor complaints, or needing prescription renewals and prevents the need to attend the Emergency Room where long waits are likely;

WHEREAS, Northern Ontario communities are geographically widespread and often isolated with an aging population. Long drives to a centre with a doctor are often difficult and in many cases a phone conversation or a virtual consultation with a doctor would work and reduce stress and safety.

NOW THEREFORE BE IT RESOLVED that the Township of Macdonald, Meredith & Aberdeen Additional request the Ministry of Health to revisit the decision to reduce virtual physician fees by 80% and fully fund this much need medical option for everyone in the Province of Ontario.

Re: Repeal Bill 23 – The Build More Homes Faster Act

Please be advised that Council for the Town of Halton Hills at its meeting of Monday, January 23, 2023, adopted the following Resolution:

WHEREAS Bill 23, the Build More Homes Faster Act was introduced on October 25th, the day after Municipal elections in Ontario at a time when councils were in a transition period and unable to respond to the legislation prior to passage of the legislation;

AND WHEREAS the Association of Municipalities (AMO) was not given an opportunity to present its concerns with Bill 23 to the Standing Committee on Heritage, Infrastructure and Cultural Policy further eroding the municipal/provincial relationships;

AND WHEREAS the loss of revenue to the Town of Halton Hills as a result of Bill 23 is estimated at \$58 -\$87 million over 10 year which, without provincial compensation, will severely impact the provision of municipal services including transportation, parks and recreation facilities;

AND WHEREAS the elimination of the Regional role in approval of official plans creates uncertainty around the planning for regional services to support the growth aspirations of the local municipalities;

AND WHEREAS the role of Conservation Authorities has been limited to natural hazards only, thereby precluding a broader role in providing expert advice and services to municipalities on natural heritage matters as part of the planning process;

AND WHEREAS AMO's evaluation concluded that there is no confidence that the measures in Bill 23 will do anything to improve the affordability of housing.

NOW THEREFORE BE IT RESOLVED THAT the Town of Halton Hills urges the Provincial Government to repeal Bill 23;

AND FURTHER THAT this resolution be circulated to Premier Doug Ford, Steve Clark, Minister of Municipal Affairs and Housing, Provincial opposition parties, Ted Arnott MPP, and AMO.
